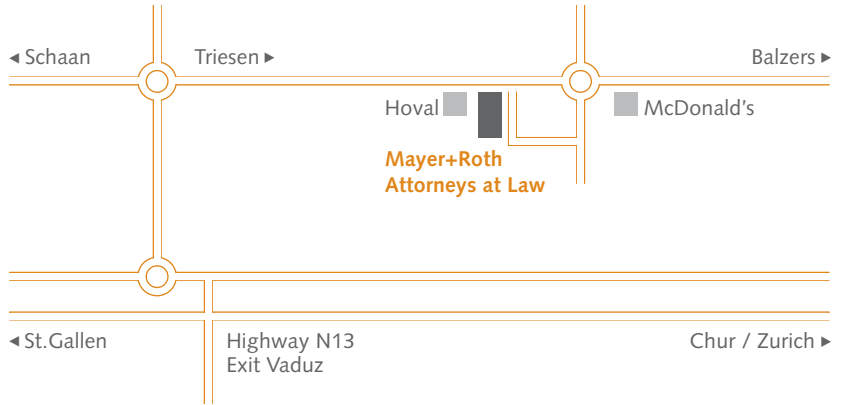


- Born in 1974, Liechtenstein citizen, married
